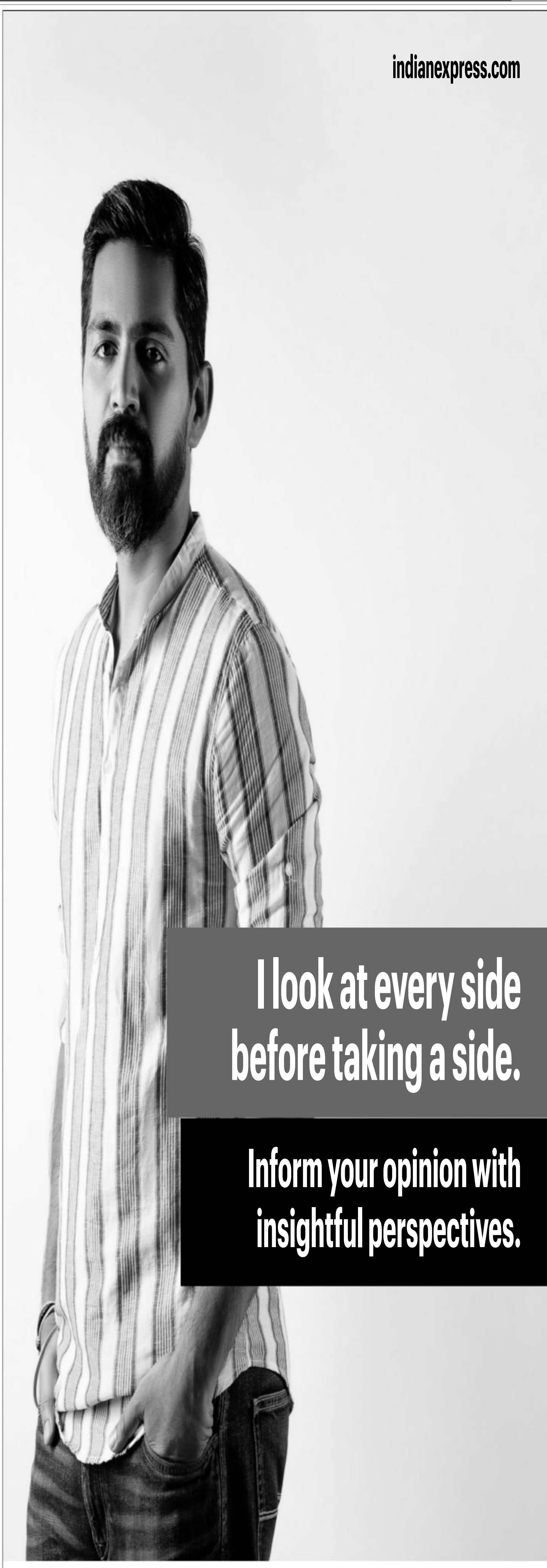

**ORDER OF THE REVIEW COMMITTEE FOR DECLARATION OF WILFUL DEFAULTERS PURSUANT TO PROCEEDINGS CONDUCTED AT HEAD OFFICE ON 27.06.2022**  
 M/s Sunrise Info Services (Rs. 1.14 Crores)  
 CS: Bangalore East / ZS : Hyderabad Date of NPA: 31.03.2021  
 in terms of RBI Master Circular No. DBR No. CID.BC.22/20.16.003/2015-16 dated July 01, 2015, Committee for Identification of Wilful Defaulters issued show cause notice dated 11-10-2021 to following person(s) mentioning the ground on the basis of which they were identified as wilful defaulters:

1. M/s Sunrise Info Services (Borrower)  
 2. Sh. Arjun Purohit (Partner/Guarantor)  
 3. Sh. Kalaram Purohit (Partner/Guarantor)

Vide show cause notice, the above named persons were given opportunity to make a representation, if they so desire, to the Bank within 15 days from receipt of notice, as to why they be not classified as wilful defaulters. In spite of service of the said show cause notice, no reply / representation was made by the above persons.

Thereafter, the Identification Committee after due consideration of the facts on record, in its meeting held on 22.11.2021 had observed that the above named persons had defaulted in payment/repayment obligations to the Bank and identified them as wilful defaulter on the following ground.

**Siphoning of Funds**  
 As per visit report dated 07-09-2020 here is nountin in the name of M/s Sunrise info Services. The borrower firm has misappropriated the entire hypothecated stocks since it has failed to submit the stock statement and sale proceeds have not been credited in loan account. The Borrower has siphoned the bank's fund.

Accordingly, the Identification Committee had issued order on 25.11.2021. In its said order, the committee had also directed that the above named persons are free to make a written representation against the order of Identification Committee, within a period of 15 days from the date of receipt of order to the Review Committee headed by the MD & CEO of the Bank.

Despite service of the order of the Committee for Identification of Wilful Defaulters of the Bank, no representation was received from the Borrower and the above named persons, mentioned at serial no. 1 to 3.

**ORDER OF THE REVIEW COMMITTEE FOR DECLARATION OF WILFUL DEFAULTERS:**  
 The Review Committee chaired by the undersigned MD & CEO of the Bank and the Directors of the Bank as members, after due consideration of the above said facts and evidence on record, in its meeting held on 27.06.2022 concurred with the order of the identification committee and found that the captioned borrower/ guarantor are responsible for the above events of wilful default, which constitute cogent ground of being declared as 'Wilful Defaulter' in terms of extant Bank guidelines issued in consonance with the RBI guidelines/Master Circular No. DBR No. CID.BC.22/20.16.003/2015-16 dated 01.07.2015 and declared M/s Sunrise info Services (Borrower), Sh. Arjun Purohit (Partner/Guarantor) and Sh. Kalaram Puro Purohit (Partner / Guarantor) as 'Wilful Defaulter' for the reason mentioned above.
